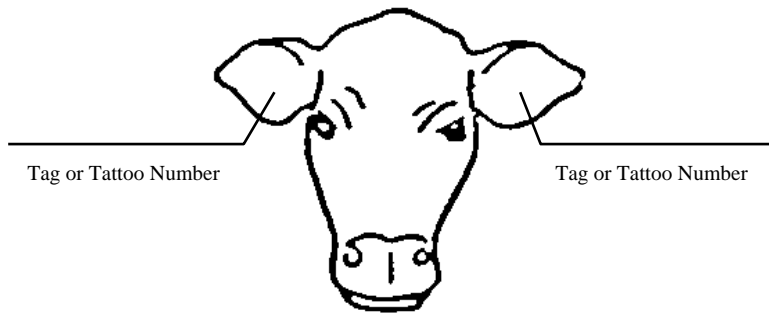

Ownership Rules of 4-H Dairy Project:

1. Animals exhibited must be owned solely by the member, member's family or leased by agreement (if leased, complete information on back of page). The family includes the 4-Hers parents or guardians and siblings living together as a family unit. The definition of family includes an extended family where the animals may be owned by grandparents with the 4-Hers parents actively involved with and working on the farm.
2. Animals owned in partnership with non-family members (as defined above) must be leased and follow guidelines within the lease agreement
3. An animal can only be exhibited by one member of the family at 4-H shows during a calendar year. No family member or other 4-H member will be allowed to show an animal that has been shown by another 4-H member after the animal's first freshening.
4. Two current 4-H Dairy Project Members from non-immediate families may own an animal together. However, said animal is the exclusive project rights of only one member in a given 4-H year. When the jointly owned project animal freshens, only one member has exclusive project rights the remaining life of the animal.
5. For each dairy animal exhibited at a 4-H show, this ownership affidavit or the leasing form must be submitted to the County Extension Office/ Regional Center prior to May 15. Dairy exhibits will be verified against the ownership affidavit at the County Fair and State Fair.
6. A 4-H member can exhibit an animal in the two year old or cow class as long as the ownership affidavit was submitted prior to May 15 and the cow's first freshening. An animal need not be shown as a calf or heifer to be eligible to be exhibited in a cow class.
7. This ID form needs to be completed only once for each animal - does not need to be completed annually. Lease agreements need to be reviewed annually.
